Your Extended Private Label Rights

Note: Please retain a copy of this license for future reference.

What You Can Do:

YES – You can edit the products however you wish, including adding your name as the signature author, adding in your affiliate link to the review templates and modifying the content however you wish.

YES – You can sell **PERSONAL** private label rights. Your customers receive personal rights only and are not allowed to resell rights of any kind! This is important – we want to limit distribution so your customers can't easily purchase this license from anyone but you!

YES – You can use the graphic source files (psd) to modify the graphics, including colors, text, layers, and gradients or create additional graphic files for the same package. Our graphics cannot be used to create other website packages with the intent of distributing PSD files.

YES – You can use our content within training programs. You can also give our content away to subscribers, but it must be distributed in PDF

format. You can only sell private label rights, they can not be given away.

YES – You can bundle content into an information product that is sold with personal rights or personal private label rights.

YES – You can use our content inside of newsletters or mailing lists or create physical products with our content.

YES – You can rebrand the templates under your name, website or company name.

What You Can't Do:

NO – You cannot include in free or paid membership sites. Sorry! We have to retain the value of our packages and protect our resellers. Offering our packages in free or paid membership sites quickly saturates the content and makes it hard for other resellers to sell our products to their customers.

You CAN include PERSONAL use licenses within paid membership sites, where you distribute the ebooks & reports in PDF format, as training tools and resources. No rights can be sold/distributed/offered within membership sites – whether paid or free.

NO – You cannot sell our entire collection in one package. While you can create bundles of our products, you can only include up to 5 of our

packages in any one collection with a price of \$27 or higher.

NO – You **cannot** sell transferable PLR, or MRR to our collections. Only personal, **NON TRANSFERABLE** private label can be sold.

You can't give PLR away. You must **sell** private label to your customer base. You must also clarify that they have **PERSONAL** use rights only, meaning that they can sell the information products, but not PLR or any distribution rights. Make this clear, please.

Note: We have created a private label license for you to give to your customers. Please be careful to distribute the correct license, as there are two in your packages – extended (the one you are reading now, which was created for you) and one called *“PLR-Customers.pdf”*, which you must distribute to your customer base.

To protect the integrity of our offer, we do not allow our content to be bundled into one collection as to mimic our offer. You can add up to 5 content packages into a collection, offer or bonus and sell **personal** PLR to the releases.

Pricing Requirements:

If selling individual packages with personal PLR, they must be sold for a minimum of \$17 each. If selling in a collection/bundle of 5 or less, the minimum price of the package (or paid offer) must be \$27.

Dime Sales & Auction Sites

We also do not allow our websites to be sold or included in dime sales, but you **can** sell the websites on Flippa as ‘completed’ websites, with a domain name and personal private label rights.

You can not offer unrestricted PLR to our packages. This is the **ONLY** way we can protect the value of your license and our products as we limit the number of reseller licenses made available.

We try not to complicate our licensing, but we also need to do our best to protect the value of our content, and the license that you purchased. I hope you will support us in our attempts of bringing quality content back into the private label marketplace.
